| A | Pay Scale and Salary | Consolidated pay equal to the revised basic pay, which corresponds to the minimum of the pay Scale (5200-20200, G.P= 2400) pre revised scale plus Dearness Allowance. | D | Other Conditions of Service | Engagement shall be terminable on either side by prior notice of one month or payment of one month's salary by the appointing authority in lieu of prior notice. Engagement shall be terminable without any further notice, whenever the post is filled-up under rules by the competent authority and the engagee shall have no claim, whatsoever, against the Government or the Appointing Authority. In the matter of discipline and conduct, engagee shall be governed by the rules, regulations and orders in vogue in the Union Territory Service on the subject. |

| E | Nature of engagement | The engagement made herein shall and shall always be on Academic Arrangement Basis only without conferment of any preferential right on the Engagee for regular appointment against the post of Jr. Staff Nurse |

3. The candidate shall report to the Office of the undersigned for joining within a period of (21) days. In case of failure of Engagee to join within a period of (21) days from the date of issuance of this Order, he shall forego his engagement which shall be deemed to have been cancelled ab-initio without any further Notice and next candidate as per merit will be considered for engagement as Jr. Staff Nurse .
4. The candidate shall be allowed to join only on production of the following documents/certificates in Original:-
- a) Date of Birth Certificate.
 - b) 10+2 with Science Certificate.
 - c) Degree/Diploma Certificate.
 - d) Year wise marks cards of Degree/Diploma Certificates.
 - e) Certificates from the concerned District Industries Centre (DIC) and District Employment and Counselling Centre to the effect that no loan under any self-employment scheme has been taken by the engagee.
 - f) Domicile Certificate.
 - g) Agreement as per format prescribed as **Form- A** appended to S.O. 364 of 2020 Dated. 27-11-2020.
 - h) An undertaking in the shape of an affidavit duly attested by Judicial Magistrate to the effect:
 - i) **that in case any adverse report about his Qualification, Date of birth, Marks Certificates etc. If any, is received from the competent authority to whom the references shall be made by the Office of the undersigned, the candidate shall have no right to claim his engagement as Jr. Staff Nurse and his engagement as such shall be deemed to have been cancelled ab-initio. He will not also claim for any dues from Govt. Unani Medical College, Ganderbal as well in that case and next candidate as per merit will be considered for engagement as Jr. Staff Nurse .**
 - ii) **that the candidate has fully understood the terms, conditions and nature of his engagement and will not claim for regularization after completion of the term or at any point of time.**

5. The Character and Antecedents of the candidate has already been got verified from CID/Police Department vide above referred communication.
6. The engagement shall be governed by the other terms and conditions, as are not specifically mentioned herein this Order but are made applicable in case of such engagement any time by the contracting authority.
7. The Services of the engaged person shall be terminated in case his performance is not satisfactory/up-to the mark.
8. The respective DDO shall keep the salary of the aforesaid contractual person on hold till the satisfactory verification report of above documents/certificates is received from the issuing authorities.
9. One month's salary of the incumbent shall not be paid till completion of the term of engagement as such in terms of existing S.O. 364 of 2020 Dated. 27-11-2020.
